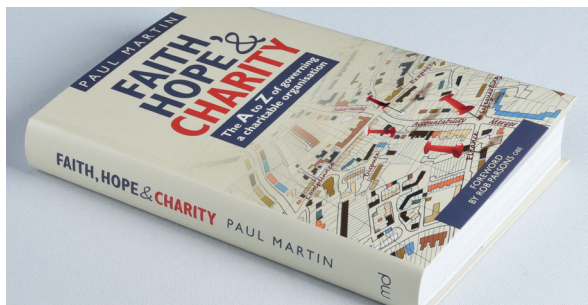


### **Julian Flitter - Goodman Jones**
